



# Opportunities to Provide Home Energy Services with New Health Funding in Arkansas

Health care professionals recognize that avoiding a health harm is preferable to treating an illness or injury after it has occurred. Energy efficiency programs provide an opportunity to deliver these preventive strategies in homes. This fact sheet provides information on several opportunities for health sector funding to be used in support of in-home energy efficiency programs.

## Medicaid Funding

A state's Medicaid rules can provide funding for in-home services via federally approved waivers and amendments to state plans. Negotiations with the Managed Care Organizations (MCOs) that serve Medicaid populations in most states can also lead to funding and support. MCO contract changes can be promoted at the state administrative level, or through partnerships with MCOs directly.<sup>1</sup>

Has Arkansas had any related waiver programs?	Yes: the <a href="#">Arkansas' Tax Equity and Fiscal Responsibility Act (TEFRA)</a> enables a demonstration project that supports children, including home-based care as opposed to institutional care.

## State Children's Health Insurance Program (CHIP) Health Services Initiatives (HSIs).

Unused CHIP funds can be invested in health-related programs known as Health Services Initiatives (HSIs). An HSI can be proposed by a state's CHIP administrator.

Does Arkansas have unused funds for an HSI? <sup>2</sup>	Yes: \$3.7 million
Does Arkansas have a related HSI?	Yes: the <a href="#">Arkansas Poison and Drug Information Center (APDIC)</a> provides telephone assistance for poison-related instances but also seeks out home exposure calls; the <a href="#">Intensive Home &amp; Community-Based Family &amp; Child/Youth Support Health Services Initiative</a> assists children with mental health challenges through home assessments; and the <a href="#">Health &amp; Well-Being Program for Maltreated Children Health Services Initiative</a> includes an evidence-based home visiting program and in-home service components for maltreated children.

## Opportunities for Action in Arkansas

Medicaid and CHIP are frequently administered through the same state agency or office. Connect with this office to learn about the potential to implement changes to Medicaid reimbursement, to develop an HSI, or to alter MCO contracts to support energy efficiency or related in-home health and safety work.

## Leverage Health in All Policies (HiAP) initiatives or advocate for new ones

Health in All Policies is a collaborative approach to integrate health considerations into policymaking across sectors.<sup>3</sup> HiAP initiatives, whether implemented as legislation, an executive order, an agency rule, a task force, or otherwise, can bring a focus on health in areas of governance not used to prioritizing health issues. These initiatives can help motivate, justify, and facilitate better integration of health considerations with other types of work, including energy policies and programs. If your state (or a local community within your state) has already adopted a HiAP approach, it could be used to facilitate collaborative conversations between health and energy policymakers. There may be an opportunity to advocate for a HiAP policy in states that don't already have one in place.
